We do expect all guests on the IRCC premises to strive with us and abide by our Christian values and follow these posted Rules and Regulations. These Rules and Regulations are guidelines designed to foster an environment that is consistent with our core values while welcoming to our extended community. Please take some time to familiarize yourself with these IRCC Premises Policies. Your agreement to abide by the IRCC's Rules and Regulations and waive and hold the IRCC harmless, is a condition of the IRCC allowing and accepting guests and participants to its facilities.

Applicability

This policy applies to all areas of the IRCC facility as well as to any guest on the property of the Irvine Rock Community Center including and not limited to: the facility, parking lot, eating areas of the property as a whole.

At all times IRCC reserves the right to immediately remove any Persons found violating the Rules and Regulations. These Rules can be accessed digitally as well as found posted throughout the facility. It is the guest's responsibility to familiarize themselves with these Rules and Regulations.

COVID-19 Advisement & Waiver

The COVID-19 epidemic is unprecedented and currently without cure or vaccine. IRCC intends to abide by all applicable health and safety rules and regulations as well all reasonably recommended precautionary guidelines. As should be obvious, but is hereby emphasized, community activities, public gatherings, and especially sports activities that invariably involve personal contact and close proximity between individuals. Contact and proximity between individuals is known to increase the likelihood of transmission of the COVID-19 virus, already understood to be highly contagious, and transmittable even by persons without symptoms. With this in mind, you knowingly agree to hold the IRCC harmless and waive any and all liability, and accept all risk associated with the increased risk of transmission of

disease, including the COVID-19 virus, inherent in community activities, group sports activities and exercise and social gatherings which is, in fact, a central purpose and function of the IRCC.

IRCC has put in place numerous preventive measures and enhanced cleaning protocols to reduce the spreading of the COVID-19 virus within the IRCC ; however, IRCC cannot guarantee that you, your child or a member of your team will not become infected with COVID-19.

By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily agree to hold IRCC harmless and assume the risk of being exposed to or infected by COVID-19.

Release of Liability
